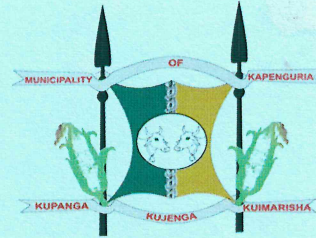

There being no other business, the meeting ended at 10:00 am with a word of Prayer from Benjamin Lemlem



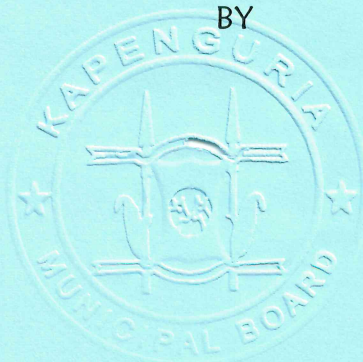


